

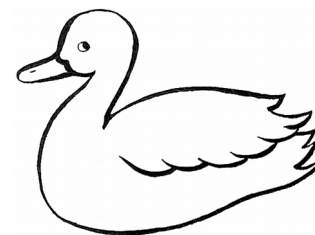

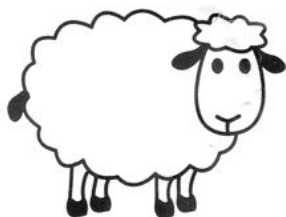

## NOTICE TO EXHIBITORS

### **Dogs Eligible to Enter the Farm Dog Certification Test**

- The FDC test is open to all dogs at least 9 months of age that are individually registered with the AKC, dogs with PAL numbers, and dogs enrolled in the AKC Canine Partners Program. Dogs in Misc/FSS are also accepted,.
- Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the test.
- If you do not receive an email confirmation a week after you send in your entries, please email the secretary at [secretary@pawtap.net](mailto:secretary@pawtap.net) to verify that your entry has been received.

## Testing Order

In order to lessen the number of handler/dog teams on the grounds during the day, tests will be run in a morning block and an afternoon block. You will receive either an AM time slot or a PM time slot for both of your tests. You can request either morning or afternoon. Your requested time slot is not guaranteed due to the number of requests received. This is the same for if you are entering both tests, or only one test.

Test 2: 10:00 AM to 12:00 PM; Judge: Linda Hahn

### Afternoon Tests

Handler Briefing: 12:30 PM

Test 1: 1:00 PM to 3:00 PM; Judge: Lori Nichol

Test 2: 3:00 PM to 5:00 PM; Judge: Linda Hahn

## Test Details

- *Test Grounds Open at 7:00 AM.* Please **DO NOT ARRIVE** prior to 7:00 AM. This location is at a personal small family farm and we need to be respectful of the family living there.
- *Running Order:* A running order will be available in the final confirmation email which will be sent out a couple of days before the test. Exhibitors are allowed to enter more than one dog.
- *Crating:* Please be prepared to crate in your car. There may be limited crating available inside the building.
- *Ribbons:* A flat green ribbon will be provided for each qualifying run.
- A title pin will be provided to those dogs who pass both legs with a qualifying score.

## Livestock

Livestock to be used will be sheep and ducks. There will be approximately 10 penned ducks and 3 sheep.

## **Additional Information**

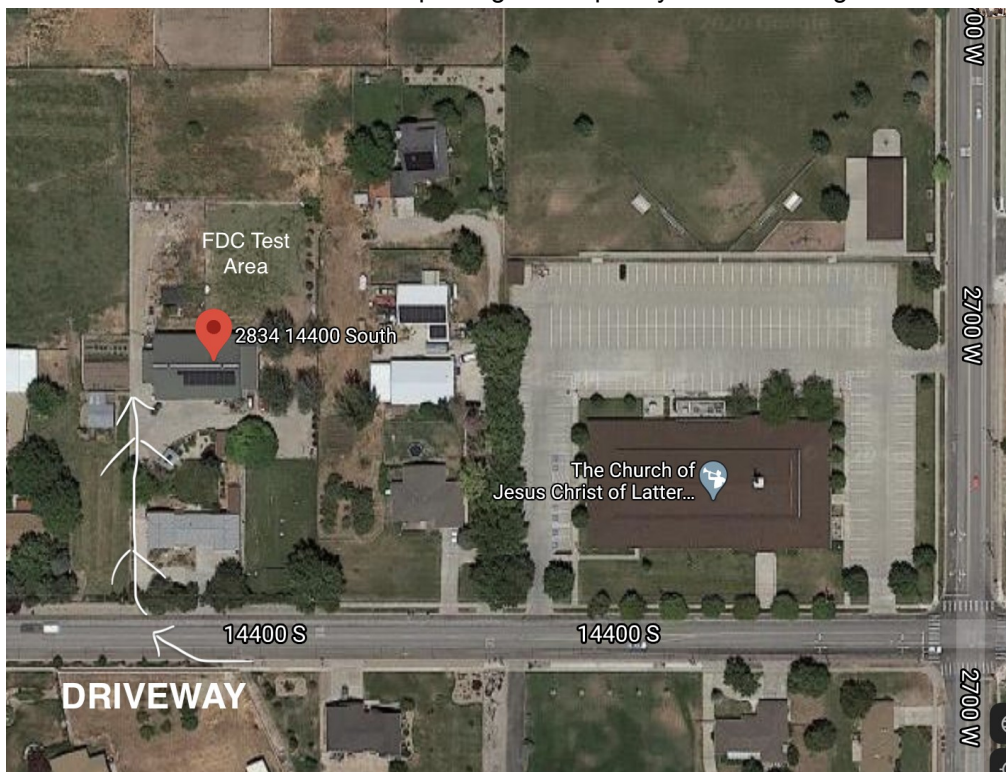
1. For Exhibition Only entries will not be accepted.
2. Dogs **MUST BE ON LEASH AT ALL TIMES!** This is an AKC rule. Off-leash dogs will be excused and required to leave the show grounds. No refunds will be given.
3. All dogs must wear a flat buckle collar as per AKC FDC rules. No harnesses, choke chains, gentle leaders, or other types of gear is allowed during the test.
4. Bitches in season will be allowed to compete. They will run at the end of the day and must wear pants. Please notify the secretary **WHEN YOU SEND IN YOUR ENTRY** if you think your bitch may be in season at the time of the test.
5. Healthy Dogs Only. If your dog shows any signs of ill-health, such as coughing, the dog will be excused and required to leave the show grounds. No refunds will be given.
6. Dogs are required to be 9 months or older to compete in the AKC Farm Dog Certified Test.
7. Dogs are required to have an AKC registration number, PAL number, or ILP number.
8. AKC FSS and Miscellaneous breeds are allowed to participate in the FDC test.
9. Weather: These tests will be held at an outdoor location. Please be advised that the weather in Utah in May can be unpredictable. If a major blizzard is expected we reserve the right to cancel the test. If the test is cancelled due to weather, full refunds will be issued. Email information will be sent out the day before if there is any concern about the weather.
10. You **MUST** clean up after your dogs! If you are found not picking up after your dog, you will be excused from the test and required to leave the show grounds. No refunds will be given.
11. Refunds will only be given for entries pulled before the closing date of Saturday, April 14, 2020, at 7:00 PM. After this date, no refunds will be given. This includes injuries (of person or dog).
12. Any entries may be declined for cause and may be refused; the test committee remove any dog on account of disease, viciousness, or other causes, and no one shall have any claim or recourse against the committee or any official thereof.
13. **Entry fees shall NOT be refunded** in the event that a dog is absent (unless replaced by an alternate), disqualified, excused by a veterinarian, judge or tester or barred from competition by the Test Committee. Any dogs aggressive to persons or stock will be removed. (See Chapter 1, Section 22 of the American Kennel Club Herding Rulebook.) If, because of riots, civil disturbance, or other acts beyond control of the Club, it is impossible to open or complete the show, no refund of entry will be made. Dogs must be ready for their classes. Test/Trial judges have the authority to refuse to judge any dog that does not appear within five minutes of being called for its run. The Test/Trial-giving Club and the Test/Trial Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

### Information regarding the FDC title

In order to receive the FDC title, the dog must pass the test two times, under two different judges. In order to receive the title from AKC, the exhibitor must also apply for the title through AKC. ### Directions to the Test Site

Coming from either the north or the south on I-15, take exit 289 for Bangerter Highway. After exiting I-15, turn west onto Bangerter Highway. Follow Bangerter until 2700 W. Turn south (left) on 2700 W. At 14400 S, turn west (right). The Hahn Homestead is the second house after the LDS church on the corner. Onsite parking will be plainly marked during the test.

I (we) agree that the judges and test committee holding this event has the right to refuse this entry for cause which the judges and test committee shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving judges and test committee, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
